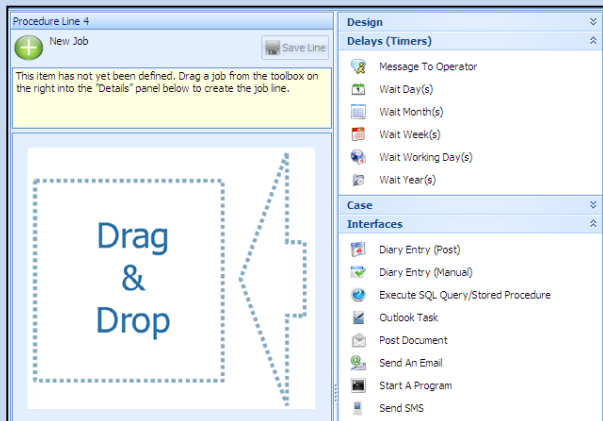

Compliance is an increasing burden on firms. The ability to impose validation during case inception assists the practice in adhering to a defined standard.



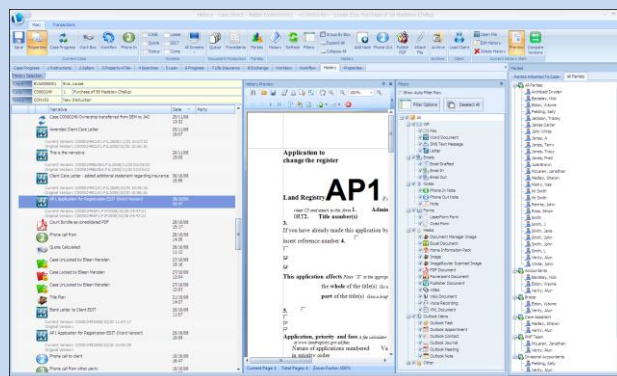
Control

Technology – keeping pace with Microsoft

Liberate SE uses the very latest Microsoft .NET technologies coupled with the Microsoft SQL Server database. As a result, our users get access to future developments from Microsoft. This ensures the longevity of the solution and protects the investment in the longer term.

User interface – fast and efficient usage

Liberate SE allows “docking” and “dragging and dropping” of the users favourite activities. As a result, each user can profile the interface as best suits them.

Tight control – manage risk and ensure compliance

A complete picture – store all information relating to a case – one click to PDF

Liberate SE records all activity on the system. A complete history is maintained of all documents, emails, images, notes etc. relating to a file. No more searching for the paper file.

Items can be printed or edited individually or sent in bulk by email or consolidated in non-amendable PDF format.

Quick to build – easy to use

Liberate SE allows the replication of existing routines and procedures. These can be quickly copied and adapted to suit new client requirements, legislative changes etc.

Workflow can be complex with options to call external SQL and web services but can also be made simple with standard case plans and basic reminders.

Advanced document manipulation

An exceptional document comparison tool allows changes between versions of documents to be easily - especially useful when collaborating with third parties. Documents can be stored in categorised folders and electronically bundled using the PDF generator. The PDF's can be annotated, indexed and paginated.
